What we are building

You may or may not be aware that Springfield Primary Academy will be undergoing a transformation, there will be a new School Building constructed on the main existing playground.

The works will also include refurbishment of the existing school with some demolition to part of the existing School. We will be carrying out the works in 3 Phases;

Phase 1 – New Build due to complete summer 2021

Phase 2 – Refurbishment of the existing School - due to complete winter 2021

Phase 3 – Demolition of Part of the Existing School - Due to complete spring 2022

Getting started

In the next few weeks, we will:

- Erect the hoarding line to segregate our works
- Start to excavate the foundations for the new build
- Pour concrete to create the foundations for the new build
- Construction Traffic will commence, which we will be restricted to set hours to minimise local disruption.
